12 server or the Sheriff, within the State of Arizona, your Response or Answer must be filed within
13 TWENTY (20) CALENDAR DAYS from the date you were served, not counting the day you
14 were served. If this Summons and the other papers were served on you by a registered process
15 server or the Sheriff outside the State of Arizona, your Response must be filed within THIRTY
16 (30) CALENDAR DAYS from the date you were served, not counting the day you were served.
17 Service by a registered process server or the Sheriff is complete when made. Service by
18 Publication is complete thirty (30) days after the date of the first publication.
