21 message to the apartment door asking the defendant to contact my office upon receipt of same.

22 5. On August 15, 2018 at 8:59 p.m., I attended to **503, 11710-100 Avenue,**  
23 **Edmonton, Alberta** and was able to gain access into the building. I attended to apartment  
24 #503 and was unable to obtain a response. At the time of my attendance I noted the message I  
25 previously left for the defendant on the 11<sup>th</sup> day of August was removed. I then posted another  
26 message to the apartment door asking the defendant to contact my office upon receipt of same.

1 I was then able to speak to an adult male neighbor who stated he has no knowledge of the  
2 defendant.
