Pursuant to this Court's Minute Entry, dated June 28, 2019, the Receiver, MCA Financial Group, Ltd., acting by and through its Senior Managing Director, Keith Bierman hereby responds to the Court's invitation to provide input relating to the setting of a shareholder meeting and the inspection of the books and records of Aztec Cooper, Inc. shareholders before the shareholder meeting is held.
